7	I. Introduction.		
8	Pursuant to OAR 860-013-0031(1), Staff of the Public Utility Commission of Oregon		
9	(Staff) asks the administrative law judge (ALJ) to abate the procedural schedule in Docket No.		
10	LC 48, with the exception of the public meeting scheduled for June 23, 2010. Staff also asks that		
11	the ALJ schedule a prehearing conference for the week of July 6, 2010.		
12	Because the current schedule requires PGE to file comments on June 11, 2010, staff		
13	requests expedited consideration of Staff's motion to abate the schedule.		
14	II. Positions of parties.		
15	Staff has conferred with counsel for Portland General Electric Co. (PGE) regarding this		
16	motion and PGE does not object. The Sierra Club, NEDC, Friends of the Columbia Gorge,		
17	Columbia Riverkeepers, and NW Energy Coalition oppose delaying the schedule. 1 No other		
18	party has informed counsel for Staff that they object to delaying the schedule, but the parties		
19	were informed of Staff's intent to request a delay only yesterday afternoon.2		
20			
21	<sup>1</sup> These parties intend to file a response to this motion no later than the end of today, June 10, 2010.		
22	At approximately 3:52 p.m. on June 9, 2010, counsel for Staff e-mailed the LC 48 service list to		
23	inform the intervenors of Staff's proposal to delay the LC 48 schedule by approximately one month. Staff counsel's e-mail set forth specific dates and invited the intervenors to reply to the e-mail by 10 a.m. on June 10, 2010, if they objected to the proposed delay. As noted above, a few		
24	parties objected to delaying the schedule. The motion staff is filing today is different from that described in yesterday's e-mail to the LC 48 parties. However, the end result is the same; a

Under the motion staff is filing, parties will have the opportunity for input regarding the replacement procedural schedule. Staff counsel's e-mail to LC 48 parties is attached to this motion. ## III. Points and authorities.

2 PGE filed its integrated resource plan (IRP) on November 5, 2009. On January 14, 2010,

3 PGE sought a stay of the procedural schedule to allow PGE additional time to explore an

4 alternative operating plan for the Boardman plant (operation until 2020). PGE noted that PGE

5 would have to obtain a rule amendment from the Environmental Quality Commission's (EQC)

6 approval in order to implement its alternative operating plan.

7 On April 2, 2010, PGE filed a petition with the EQC asking it to modify its 2009 air

8 pollution control rules for the Boardman coal-fired power plant. The Department of

9 Environmental Quality (DEQ) has recommended that the EQC deny PGE's petition and has

asked the EQC to direct the DEQ to initiate rulemaking that is based on a wider range of options

as the starting point for revising regional haze pollution controls consistent with an early closure

of the Boardman plant.<sup>3</sup> The EQC must act on PGE's petition for a revision to air pollution

control rules for the Boardman plant no later than July 1, 2010, and is scheduled to consider

14 PGE's petition and the DEQ's recommendation at a hearing on June 17, 2010.<sup>4</sup>

Staff asks the ALJ to abate the LC 48 procedural schedule and schedule a prehearing

conference the week of July 6, 2010. At that prehearing conference, the ALJ can establish a new

procedural schedule that will give parties sufficient opportunity to incorporate any impact of

pending actions by the EQC and DEQ into their LC 48 analysis.

Staff does not ask that the ALJ reschedule the June 23, 2010 public meeting to be held in

20 Portland. The Sierra Club and other parties have informed Staff that moving the meeting would

21 be a hardship.
