STAFF MOTION TO MODIFY PROCEDURAL
SCHEDULE

Staff of the Public Utility Commission of Oregon (“Staff”) asks the administrative law judge (“ALJ”) to modify the procedural schedule in this docket to allow the Commission to consider Docket No. LC 48 at a special public meeting, rather than at a regularly-scheduled public meeting, and to allow Staff additional time in which to file and prepare recommendations and a draft proposed order.

The current schedule is as follows:

October 11– Staff files recommendations and proposed order

October 27—PGE and intervenors file reply comments/intervenors reply to PGE’s response to bench request

November 9, 2010 – public hearing on LC 48 at regularly-scheduled public meeting

Staff asks the ALJ to modify the procedural schedule to the following:

October 15, 2010 – Staff files recommendations and proposed order

October 29, 2010— PGE and intervenors file reply comments/intervenors reply to PGE’s response to bench request

November 12, 2010—special public meeting re: LC 48

Counsel for Staff e-mailed the parties of LC 48 at 7:47 a.m. on Monday, October 4, 2010, notifying them of staff’s proposed request to modify the schedule and asking parties to respond by 10 a.m. on Tuesday, October 5, 2010, if they objected. No party indicated that they objected to the proposed schedule. Representatives of the Oregon Department of Energy, Portland General Electric Company, International Brotherhood of Electrical Workers Local 125, Northwest and Intermountain Power Producers Coalition, the Sierra Club, Columbia

1 Riverkeepers, Friends of the Columbia Gorge, Northwest Environmental Defense Center, and
2 Power Resources Cooperative stated that these parties did not object to the proposed schedule
3 change.

4 Staff anticipates that several parties will attend the public meeting regarding LC 48 and
5 that accordingly, a special public meeting is a more optimum forum. Furthermore, given the
6 number and volume of comments received from intervenors, as well as the number of filings
7 from PGE in this docket, Staff needs additional time to complete and file its recommendations.
