CORRECTED RULING

DISPOSITION: MOTION TO REVISE SCHEDULE GRANTED

On January 15, 2010, the Public Utility Commission of Oregon (Commission) stayed the proceedings in this docket to allow Portland General Electric Company (PGE) time to include an alternative operating plan for its Boardman plant in its 2009 Integrated Resource Plan (IRP). On April 9, 2010, PGE filed an addendum to its 2009 IRP with a new preferred Action Plan regarding its Boardman plant, as well as a motion to revise the schedule in this docket.

Procedural Schedule

In its April 9, 2010, motion, PGE submitted a proposed revised schedule. PGE noted that it circulated the proposed schedule to all parties in the docket, and did not receive any objections.

PGE's motion to revise the schedule is granted. I adopt the following schedule:

Request to Make Presentation at May 25, 2010, Public Meeting

On April 12, 2010, the Sierra Club, Columbia Riverkeeper, Friends of the Columbia Gorge and the Northwest Environmental Defense Center (Sierra Club, et al.) filed a response to PGE's motion to revise procedural schedule. Sierra Club, et al. requested the

opportunity to present their concerns with PGE's IRP at the Commission's May 25, 2010, public meeting in Salem. On April 13, 2010, PGE filed a reply to Sierra Club, et al. stating that if its intervenors are permitted to present their concerns at the public meeting, PGE requests equal time to respond.

The Commission's public meetings are open to members of the public. Accordingly, PGE and intervenors may appear and make presentations at the May 25, 2010, public meeting, subject to <u>any time restrictions that might be imposed by the Commission Chair</u>.

Request for Portland Public Meeting

In their April 12, 2010, response to PGE's motion, Sierra Club, et al. requested a public meeting in Portland, to be held sometime between June 11 and July 9, 2010, preferably on an evening between June 18 and July 1, 2010. In its motion to revise procedural schedule, PGE likewise noted that the Northwest Energy Coalition (NWEC) requested that the schedule include an evening public meeting in Portland, and that the City of Portland, Ecumenical Ministries of Oregon, and Sierra Club, et al. concurred with NWEC's request. PGE neither objected to nor supported the request for a Portland public meeting.

The request for an additional public meeting in Portland is under consideration. The Commission will notify the parties if a public meeting will be held.
