PREHEARING CONFERENCE MEMORANDUM

A prehearing conference was held in this matter on November 30, 2009, at Shady Cove, Oregon. At the conference, Roy Stuart appeared on behalf of Whispering Pines Estates Water company (the Company), and AAG Jason Jones and Staff principal Renee Sloan appeared on behalf of the Public Utility Commission of Oregon Staff.

Prior to the prehearing conference, the Commission convened a Public Comment Open House for customers of the water company. About 25 persons attended. Six customers filed petitions to intervene in this proceeding. Those Intervenors are: Bevan Ruschenberg, Spanky Cramer, Karen McMahon, Karyle A. Pasley, William Leffler, and Bob and Anna Bickford. As customers of the water company, each petitioner has a substantial interest in the case. Each of their petitions is granted, subject to the filing of a timely protest. ¹

At the conference, the Commission Staff (Staff) presented a proposed schedule. Following a discussion among all parties, the schedule was slightly modified. The revised schedule is as follows:
