NOW COMES Smart Grid Oregon (“SGO”), by and through Lisa Adatto, and respectfully moves the Commission in the above-referenced proceedings pursuant to OAR 860-001-0140, or such other statutory procedural authority as may be appropriate, to accept the late filing of intervention and these closing comments for the following reasons:

- A. SGO is a Domestic Non-Profit Corporation comprised of a growing number of entrepreneurs, service providers and business leaders, as well as non-profit organizations and educators dedicated to the growth and promotion of Oregon’s smart grid industry. SGO’s mission is “[t]o enable, promote and grow the smart grid industry and infrastructure in the State of Oregon.”
- B. SGO has been monitoring these proceedings and understood, after discussing with PUC staff, that it could present an abbreviated closing comment provided it did not open new issues of fact but would only add its opinion to the existing parties’ comments and that this would be of value to the Commissions’ ongoing deliberations. SGO has previously participated in relevant dockets and sees UM 1461 as hosting several issues relevant to SGO’s membership.
- C. SGO filed its comments and motion to intervene before the April 1, 2011 deadline but did not adequately limit its notice of service to three individuals pursuant to OAR 860-001-0180.
- D. The PUC’s filing office informed SGO of this issue and this Motion for Late Intervention is submitted to remedy this procedural error.
- E. SGO’s delay in intervening and its submission of its closing comments will not unreasonably broaden the issues, burden the record or unreasonably delay the

proceedings. SGO believes its comments are concise and useful to the Commission with respect to its drafting of an Order in this matter.

WHEREFORE, SGO respectfully requests that the Commission provide expedited treatment of its motion and grant SGO's late intervention.
