1 The Citizens’ Utility Board of Oregon (“CUB”) respectfully responds to the bench
2 requests issued by Administrative Law Judge (“ALJ”) Allan Arlow on May 5, 2014. Bench
3 requests 1-4 were directed to each incumbent local exchange carrier (“ILEC”). Bench request 5
4 was directed to all parties in the UM 1481 Phase III proceeding.

5 **For all parties:**

6 5. For each OUSF-supported exchange: all non-ILEC providers of terrestrial-based broadband
7 services, including, but not limited to, cable and wireless providers.

8 a. For each such provider, information as to whether it offers telephony services over
9 those facilities.

10 b. For each such provider, whether such telephony services are offered over its own
11 facilities or via resale of ILEC-provided facilities.

12 c. For each such provider, the market penetration of broadband services.

1 **Response:** CUB is the statutorily designated consumer advocate for the residential ratepayers of
2 utilities regulated by the Oregon Public Utility Commission. CUB is monitoring this proceeding
3 to ensure that the interests of its members and Oregon's residential ratepayers are represented.
4 Accordingly, it does not possess the information requested in bench request 5.
