

The Parties, by signing this Joint Motion, agree that the Commission should approve the Stipulation as a full and complete resolution of the issues presented in Phase III of this case, as set forth below. The Parties agree to support the Stipulation at a hearing, should one be deemed necessary, and recommend that the Commission issue an order adopting the entire Stipulation.
