III. Nature and Extent of Petitioner's Interest in This Proceeding

This docket is a Commission Staff request for investigation of the Oregon Universal Service Fund ("OUS"). Qwest is the largest incumbent local exchange carrier (ILEC) authorized to provide telecommunications services in Oregon. Like many telecommunications providers in the state of Oregon, Qwest has an interest in the investigation of the OUS. Further, Qwest has an interest to make sure that this matter is considered and resolved in a reasonable, competitively neutral and nondiscriminatory manner.
