

NOTICE OF PROPOSED
ASSESSMENT

The Public Utility Commission of Oregon (Commission) proposes to assess \$100.00 against you for Residential Service Protection Fund (RSPF) surcharge remittance late payment penalties, interest, and late report fees for June 2013.

As a telecommunications provider, you are required to submit monthly RSPF surcharge remittance reports and payments to the Commission. *See* OAR 860-033-0006. More specifically, OAR 860-033-0006(4) requires telecommunications providers to submit monthly surcharge remittance reports and payments to the Commission on or before the 21st calendar day after the close of each month. You failed to meet the requirements set out in OAR 860-033-0006(4) as follows: the June 2013 RSPF Surcharge Remittance Form was due 7/22/2013 but has not yet been received.

Pursuant to OAR 860-033-0006 and OAR 860-001-0050, the Commission proposes to assess against you \$100.00 which includes the following charges: RSPF surcharge remittance(s), late payment penalties, interest (calculated to the date of this Notice), and late report fee(s) for June 2013. Please note that specific amounts for each assessed charge are not included in this Notice to protect the confidentiality of your underlying records. If you wish to know the specific amount for each assessed charge, please contact Kathy Shepherd at kathy.shepherd@state.or.us, (503) 378-4927.

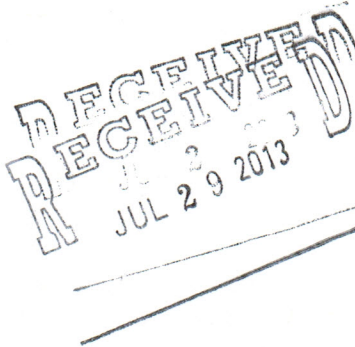
Where applicable, the interest amount is calculated as of the date of this Notice. Interest will continue to accrue at 9 percent per annum until the Commission receives full payment. *See* OAR 860-033-0006(7).

The Commission will terminate this proceeding if you fulfill your RSPF obligations as stated in this Notice by 5:00 p.m. on 9/13/2013. RSPF forms and instructions are available at <http://www.puc.state.or.us/PUC/telecom/rspf>. The Commission will review your submitted RSPF surcharge remittance reports for accuracy and completeness.

RE: Failure to File a Surcharge Remittance Form 751 – Late Fee Assessed (June 2013)

INETWORKS GROUP INC is late in filing the Residential Service Protection Fund (RSPF) Surcharge Remittance Form 751 for June 2013. The RSPF Surcharge Remittance Form 751 was due on July 22, 2013.

Oregon Administrative Rules (OAR) 860-033-0007(1) allows the Commission to make an estimated surcharge assessment. Based upon the data INETWORKS GROUP INC previously reported on Form 751, the Commission assesses a surcharge amount of \$0.00. Pursuant to OAR 860-001-0050, the past due RSPF Surcharge Remittance Form 751 is subject to a late report fee, late payment penalty, and an interest charge as follows:

- Late report fee: \$100.00
- Late payment penalty: \$0.00 (9% of the amount due not to exceed \$500.00)
- Interest charge: \$0.00 (9% per annum from the original due date up to July 23, 2013)

If you have not already done so, please file your RSPF Surcharge Remittance Form 751 and pay the late fee totaling **\$100.00** online at www.rspf.org or by sending payment to the above address by **August 07, 2013**. Failure to pay will result in issuance of a NOTICE OF PROPOSED ASSESSMENT, may be a violation of your company's certificate of authority to offer telecommunications service in Oregon, and may be grounds for cancellation of that certificate, if applicable.
