REPORT OF THE PARTIES



9 Representatives of Virgin Mobile, Staff and CUB (the parties) met on August 8, 2011, for
10 a workshop to discuss Virgin Mobile's application for ETC/ETP designation. At the meeting the
11 parties agreed that Virgin Mobile would submit an amended application that they hope will meet
12 all designation requirements and address remaining issues. Staff and CUB agreed to provide
13 comments on drafts of the amended application with the hope that the new application can be
14 made acceptable to Staff and intervenors in this docket. There is just one open issue at this time
15 and discussions are continuing toward resolution of that issue.

16 Because the parties are attempting to negotiate an amended application that will pass
17 muster with Staff and CUB, and because there is no way to determine how long that process will
18 take, the parties at this time are not asking ALJ Arlow to establish a new schedule. Rather, the
19 parties recommend that ALJ Arlow set a new date for a status report. They suggest that the due
20 date for that report be September 15, 2011.
