Pacificorp d/b/a Pacific Power (Pacificorp) submits for filing with the Public Utility Commission of Oregon (Commission) its Bi-Annual Report for the period February 1, 2023, through July 31, 2023, for the Oregon Solar Incentive Program. This filing is submitted in compliance with OAR 860-084-0430.

Summary of Pilot Program – February 1, 2023, through July 31, 2023

Pacificorp has offered 10 reservation periods for capacity under the Solar Photovoltaic Incentive Rate Pilot Program. The available capacity in the first three reservation periods was fully subscribed within minutes. The October 3, 2011, reservation period saw significant changes that resulted in the reservation period closing with capacity remaining available for small-scale projects. The April 2, 2012, reservation period experienced a return to a fully subscribed program that has continued through May 1, 2015.

Details of the results of each reservation period are provided below. Please note that the only update to these results are for the May 1, 2015, reservation period. The following results for the July 1, 2010, through the April 1, 2014, reservation period are repeated from previous reports for convenience and continuity.

Reservation Period Results

The July 1, 2010, reservation period concluded with 61 projects fully interconnected with contracts in place, and operating. Sixteen (16) projects have withdrawn their reservation or failed to meet the two-month deadline as required by OAR 860-084-0210(1).
