## RE: RE 36 – PacifiCorp's Major Shareholder Report per OAR 860-027-0175(4)

In compliance with OAR 860-027-0175(4), PacifiCorp, d/b/a Pacific Power (PacifiCorp) submits this report of the company's actual knowledge of a Schedule 13D filing made with the Securities and Exchange Commission (SEC) by a major shareholder affecting the percentage of beneficial ownership in the company. On July 11, 2017, Berkshire Hathaway Inc., made a 13D filing with the SEC, which disclosed Warren Buffett's ownership percentage changed as a result of stock donations made on July 10, 2017. Therefore, Warren Buffett's percentage of beneficial ownership in Berkshire Hathaway Inc. has changed from that reported in PacifiCorp's March 23, 2017 Supplemental Major Shareholder Report. Warren Buffett's percentage of beneficial ownership in Berkshire Hathaway Inc. is now 31.41%.
