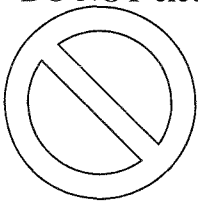

The purpose of this letter is to notify the Public Utility Commission of Oregon (Commission), that under OAR 860-039-0055(2), PacifiCorp, d/b/a Pacific Power (PacifiCorp or Company), and [REDACTED], a net metering customer, have agreed to a new 12-month annualized billing period. OAR 860-039-0055(2) requires that the annual billing cycle for net metering customers end at the end of the March billing month each year, unless the utility and net metering customer agree to a different annual billing cycle. This section also requires the utility to notify the Commission within 30 days of a utility and a net metering customer reaching an agreement for a different annualized billing cycle. PacifiCorp and [REDACTED] reached agreement for a new annualized billing cycle on December 15, 2015. The new annualized billing cycle for [REDACTED] will end with the October billing period of each year.
