**Re: RE 42—Annualized Billing Cycle Exception**

PacifiCorp, d/b/a Pacific Power (PacifiCorp) provides notice to the Public Utility Commission of Oregon (Commission), that subject to OAR 860-039-0055(2), the company and the net metering customer addressed in the attached letter have agreed to a new 12-month annualized billing period. OAR 860-039-0055(2) requires that the annual billing cycle for net metering customers end at the end of the March billing month each year, unless the utility and net metering customer agree to a different annual billing cycle. This section also requires the utility to notify the Commission within 30 days of a utility and a net metering customer reaching an agreement for a different annualized billing cycle.

PacifiCorp and the customer addressed in the attached letter reached agreement for a new annualized billing cycle on June 12, 2023. The new annualized billing cycle for this customer will end with the April billing period of each year.
