
Re: RE 63—Report on Excess Energy from Net Metering Facilities

Enclosed for filing is PacifiCorp's, d/b/a Pacific Power, annual report on the unused kilowatt-hour credits and dollar amount transferred to the low-income assistance program, consistent with OAR 860-039-0060(3) for standard net metering systems and OAR 860-084-0240(2)(c) for Oregon Solar Incentive Program systems.

As of the end of the March 2020 billing period, PacifiCorp accumulated 1,946,472 kilowatt-hours (kWh) from standard net metering and 333,294 kWh from the Oregon Solar Incentive Program. PacifiCorp has transferred \$66,794.43 to the Oregon Energy Fund (previously known as Oregon HEAT).
