1 consideration of four issues to Phase II. On September 29, 2014, Administrative Law Judges 2 (ALJs) Kirkpatrick and Pines issued a memorandum establishing the procedural schedule for Phase II of Docket No. UM 1610, which included a December 5, 2014 due date for proposed 3 4 issues. On December 4, 2014, ALJ Pines granted Staff's request for additional time to finalize 5 and file stipulations among several parties addressing the Phase II Issues List and some 6 substantive issues. ALJ Pines granted Staff's January 12, 2015 request for another extension of 7 the time in which to submit the stipulations and to suspend the remainder of the procedural 8 schedule. Under ALJ Pines' January 12, 2015 ruling, parties had until February 17, 2015, to 9 submit their stipulations to ask the ALJs to add issues to the Phase II Issues list. Staff asked for 10 an additional one-day extension of this date on February 17, 2015, and another one-day 11 extension on February 18, 2015. 12 The Stipulating Parties met on October 14 and 28, November 18, 2014, and February 5, 13 2015, to determine whether they could agree on what issues should be considered in Phase II and 14 whether they could agree on the merits of any of these issues. 15 II. Stipulations 16 The first stipulation, the Stipulation re: Issues List, is an agreement to ask the Commission to 17 consider five additional contested issues in Phase II. The second, the Stipulation, is an 18 agreement to a number of substantive issues. The parties to the stipulations are Staff of the 19 Public Utility Commission of Oregon (Staff), Portland General Electric Company (PGE), 20 PacifiCorp, Idaho Power Company (Idaho Power), One Energy, Inc., Obsidian Renewables LLC 21 (Obsidian), the Community Renewable Energy Association (CREA), the Renewable Energy 22 Coalition (REC), and the Oregon Department of Energy (ODOE), and Small Business Utility Advocates (SBUA).1 23 24 25
