

Pursuant to the requirements in OAR 860-084-0430, enclosed please find a copy of Idaho Power Company's ("Company") **CONFIDENTIAL** bi-annual report for the Solar Photovoltaic Pilot Program data as of July 31, 2019. The Company currently has 60 signed contracts with 60 systems on-line.

April 1, 2014, was the date of the last enrollment period. The final project came on-line April 15, 2015, bringing the program to full capacity. The report submitted on August 15, 2018, was the last time the content in this report was updated, for one change due to a new participating customer from transfer of ownership of property and project.
