Pursuant to the requirements in OAR 860-084-0430, enclosed please find a copy of Idaho Power Company's ("Company") **CONFIDENTIAL** bi-annual report for the Solar Photovoltaic Pilot Program data as of July 31, 2021. Because it contains detailed customer information, the attached report should be treated as a confidential submission under OAR 860-001-0070 and OAR 860-084-0420. The Company currently has 60 signed contracts with 60 systems on-line.

April 1, 2014, was the date of the last enrollment period. The final project came on-line April 15, 2015, bringing the program to full capacity. Three changes are included on the July 31, 2021 report: one new participant due to transfer of ownership of the property and associated project (project 4), and data corrections for owners of two projects which were transposed (projects 53 and 55). Otherwise, all other report contents remain the same as the report submitted on February 12, 2021.
