c) PGE is a public utility subject to the jurisdiction of the Commission. Decisions made and precedent established in this proceeding may directly affect PGE.


d) PGE intends to participate in this proceeding and, if necessary, raise issues that are appropriate to the proceeding. No other party could adequately represent the interests of PGE.


