
MEMORANDUM IN SUPPORT





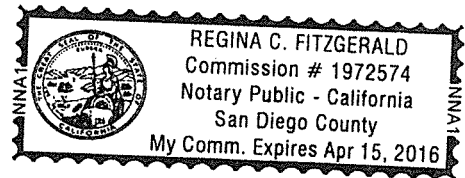
