Staff files this status report regarding Phase II of this docket. The parties held two additional workshop/settlement conferences addressing initial application requirements for Eligible Telecommunications Carriers (ETCs) on November 4, 2014 and November 25, 2014. The parties discussed initial ETC designation to provide Lifeline services. The parties have reached agreement on nearly all of the issues. The parties are now in the process of scheduling an additional workshop/settlement conference in January 2015, which will focus on the requirements for designation to receive high-cost funds. Staff proposes to file another status report on or before February 15, 2015.
