8 Staff of the Public Utility Commission of Oregon (Staff) asks the Administrative
9 Hearings Division of the Commission to schedule a pre-hearing conference in Docket No. UM
10 1648 for the purpose of setting a procedural schedule for additional proceedings. Additional
11 proceedings are necessary to address the issue of annual reporting requirements for the re-
certification of eligible telecommunications carriers.

12 Staff requests that a prehearing conference be scheduled on or about April 4, 2014. Staff


