NATURE AND EXTENT OF THE PETITIONER'S INTEREST IN THE
PROCEEDINGS:

Warm Springs Telecom (WST) is a CLEC entirely owned by the Confederated Tribes of Warm Springs, serving the reservation of the Tribes. WST is an ETC that presently receives Oregon Universal Service Funds. In this proceeding, WST is interested in both the general ETC issues raised as well as the issues of ETCs serving tribal lands when such ETCs do not serve the entire reservation.

THE ISSUES THE PETITIONER INTENDS TO RAISE IN THE PROCEEDINGS:

- Issues of certification for ETC – that ETCs should only be certificated if they able to provide service in areas in which they have (or intend to have and can prove intent) full coverage in that area/wire center.
- ETCs serving on tribal lands should offer federal Tribal lifeline rates,
- ETCs serving tribal lands should provide services in entire wire centers or on entire reservation.
