16 The Complainant Columbia Basin Electric Cooperative (the "Cooperative") requests ruling to lift the
17 temporary suspension of the procedural schedule in this docket. The Cooperative has attempted to reach a
18 settlement with Defendants Pacific Power and North Hurlburt Wind, LLC. The Parties have failed to reach a
19 settlement. Pacific Power and North Hurlburt Wind, LLC do not take a position regarding the filing of this motion.
20 Umatilla Electric Cooperative and Oregon Rural Electric Association do not oppose this filing.

21 **BASIS FOR MOTION**

22 At the settlement conference on December 3, 2013, Pacific Power, North Hurlburt Wind, LLC and the
23 Cooperative discussed general terms for settlement of all issues in this docket. Although those parties tentatively
24 agreed on a framework for settlement, the Parties have been unable to agree on key components of a mutually
25 satisfactory settlement.

26 The Cooperative asks for a ruling to lift the temporary suspension to the procedural schedule in this proceeding. The Cooperative recognizes that the dates set forth in original procedural schedule in this proceeding

1 are currently out of date and would not be applicable for remainder of this proceeding. The Cooperative requests
2 that the Administrative Law Judge set a conference call for the Parties and the Judge to develop a new schedule for
3 the future proceedings in this docket.
