Dear Judge Kirkpatrick:

Pursuant to your Prehearing Conference Memorandum issued February 13, 2014, Frontier submits this status report on behalf of the Company, PUC Staff, CUB, Integra Telecom Inc., and PriorityOne Telecommunications, Inc. (collectively, the Joint Parties).

Frontier has reduced a draft stipulation and price plan to writing and has circulated same to the Joint Parties. The Joint Parties have indicated they are reviewing those documents and will make suggested changes and discuss issues with the Company in due course.

Frontier anticipates that on or before April 15<sup>th</sup>, 2014, Frontier and the Joint Parties will either file the agreed-upon final version of the stipulation and price plan, or will file a subsequent status report to update the ALJ.

A copy of this letter has been circulated to the Service List and no objection to the status report was made by any party.


