Dear Commissioners and Staff,

In the above referenced docket and order, the Commission approved a Price Plan (the "Plan") for Frontier Communications Northwest, Inc. ("Frontier" or the "Company") effective August 18, 2014. One of the provisions of the Price Plan requires Frontier to file a report comparing the Company's performance to the Plan's objectives by the 90th day of the third year of operation under the plan. Under this condition, Frontier's report would be due to the Commission on or about November 18, 2016.

Frontier has learned it needs additional time necessary to collect, organize and analyze the data requested by the Commission, and to provide more robust and responsive answers to the Commission's questions about how the specific objectives of the Plan are being met. As a result, we now plan to submit the report no later than January 18, 2017.

Although the Plan has only been in effect for two years, Frontier recently renewed its commitment to the success of the Plan by notifying the Commission in August that it was electing to extend its Price Plan for a fourth year. The Company has completed all of the network infrastructure improvements that it committed to in the Plan, and strongly believes that its customers are enjoying all of other the benefits of the plan as well. The additional time required to prepare the report will allow Frontier to provide all of the most current and relevant information necessary for the Commission to affirm that the Plan is meeting its goals and is still in the public interest, as it concluded in the Order.

We have discussed the filing date change with Bryan Conway, Administrator, Telecommunications and Water Division, for Commission Staff and he is not opposed.
