I, JOHN CRIDER, being first duly sworn on oath, depose and say:

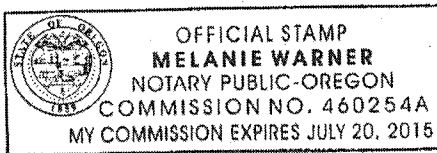
1. My name is John Crider. I am a Senior Analyst employed by the Public Utility Commission of Oregon ("Commission").


