

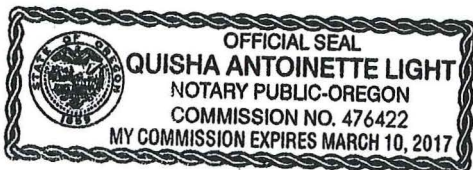
I, MIKE NIMAN, being first duly sworn on oath, depose and say:


