2. I sponsored the following three exhibits on behalf of Commission Staff in this matter: Staff/100, Staff/101 and Settling Parties/100.

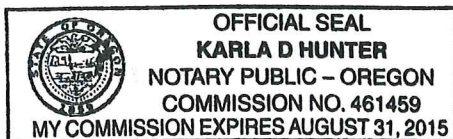


