For the reasons set out below, Portland General Electric Company (“PGE”) hereby requests that the remaining procedural schedule in this docket be suspended.

This docket was initiated when PGE filed its annual tariff Schedule 126 power cost variance mechanism update on June 3, 2014. PGE’s filing included the information required by the minimum filing requirements agreed to for such dockets. The Citizens’ Utility Board (“CUB”) and the Industrial Customers of Northwest Utilities (“ICNU”) intervened in the docket. No other party sought intervention.

Settlement discussions between PGE, Staff of the Public Utility Commission (“Staff”), CUB, and ICNU (collectively the “Stipulating Parties”) were held on August 14, 2014. As a result of those discussions, an agreement in principle resolving all issues in this docket was reached among the Stipulating Parties. The Stipulating Parties are in the process of completing a stipulation and supporting joint explanatory brief and anticipate filing the stipulation and brief next week.


PGE respectfully requests that the remaining procedural schedule in this docket be suspended. The other Stipulating Parties support this motion.

## CONCLUSION

For the reasons discussed above, PGE requests that the administrative law judge issue an order suspending the remaining procedural schedule in this docket. Because Staff and Intervenor testimony is due September 4, 2014, PGE requests expedited consideration of this motion.
