Customers with this feature on their telephone line can only make calls to those prefixes available for local, EAS, and 800 calling. A customer may choose to subscribe to Toll Restricted Service for \$1.00 month.

The Company may waive charges for Toll Restricted Service as part of an agreement with a customer in arrears and will waive the charge when Toll Restricted Service is used as part of the Company's credit or collection policy initiated by the Company.

Lifeline subscribers may subscribe to toll blocking at no extra charge. Toll blocking is a service provided that allows OTAP recipients to elect not to allow the completion of outgoing toll call from their telecommunications circuit (OAR 86-033-0005(9)). Lifeline subscribers who subscribe to toll blocking will not be required to pay service deposits in order to initiate service.

With this service the Subscriber gets an Emergency Line that provides a residential one-party access with certain limitations. The line will be toll blocked and will not have a directory listing. The line will allow outgoing E911, 711 abbreviated dialing, and Local/EAS calling with unlimited incoming calls.

Monthly Rate is 0.5749 of the current Residential 1 party rate.
