Attached you will find the above-referenced tariff sheet. This filing increases the residential rate from \$14.00 per month to \$16.00 per month effective November 30, 2014. This filing affects 333 residential customers. The filing will provide annual revenue of \$7,992.00.


The purpose of this filing is to conform to FCC Order No. 11-161. In the course of that Order, the Federal Communications Commission adopted new rules concerning the universal service program. The effect of those rules is to penalize any company whose residential rate plus certain state fees is less than \$16.00 on December 1, 2014. The penalty is a dollar-for-dollar reduction in universal service support for the Company's operations.

The Notice to customers is attached and includes additional information concerning the filing.

**Vacation Service**

Vacation rate service is available upon advance notice to the company. Local exchange service will be billed on a monthly rate of a minimum of \$6.50 for residential/business line and \$10.00 for DSL for a period of not less than one calendar month, which corresponds to the billing period and not more than six months. Vacation service is defined as providing dial tone for the purposes of access to Emergency 9-1-1 service and the Company's business office.

Federal Lifeline and OTAP credits are not applicable with this service.

**Important Notice about Your Telephone Rates**

Effective November 30, 2014, Eagle Telephone System, Inc. will be increasing the One-Party Residential service rate to \$16.00 per month. The rate change is in response to regulatory reforms issued by the Federal Communications Commission including reduction in inter-carrier compensation. In addition, without a rate change, Eagle will lose some of its federal Universal Service Support. Federal Universal Service Support helps keep the network serving you as affordable as possible.

Customers may petition the Public Utility Commission of Oregon to investigate the rate increase. The Commission will investigate the rate increase if it receives petitions signed by 10 percent of customers or 500, whichever is the lesser, on or before November 21, 2014. If the Commission does not receive sufficient petitions by November 21, 2014, the proposed rates will become effective on November 30, 2014 without Commission review. Petitions should be sent to the Commission's Consumer Services Division. The Company will provide a current copy of the local exchange directory and its service territory map within ten days of a request from any customer.
