**JOINT NOTICE TO ADMINISTRATIVE  
LAW JUDGE CONCERNING SCHEDULE**

7 Staff of the Public Utility Commission of Oregon (Staff) hereby informs the  
8 Administrative Law Judge (ALJ) that Idaho Power Company (Company), the Citizens' Utility  
9 Board of Oregon (CUB), and Staff (collectively referred to as the Parties) have agreed to waive  
10 the following events set forth in the schedule governing these proceedings: "Staff and  
11 Intervenors file Opening Testimony on February 10, 2015" and "All Parties file Reply/Cross  
12 Answering Testimony on March 17, 2015."<sup>1</sup> See Prehearing Conference Memorandum issued  
13 on November 21, 2014 (setting forth the schedule). The Parties have agreed to waive these  
14 events because Staff and CUB have no issues to discuss in relation to the Company's October  
15 Update for the 2015 Annual Power Cost Update (and thus no Party has reason to file either  
16 Opening or Answering Testimony).

2 not meant to impact the other events currently set forth on the schedule. The Company will still  
3 file its March Forecast, and CUB and Staff will review it, under the timeframes set forth in the


