**MOTION TO SUSPEND
REMAINING PROCEDURAL
SCHEDULE**

**EXPEDITED CONSIDERATION
REQUESTED**

For the reasons set out below, Portland General Electric Company (“PGE”) hereby requests that the Administrative Law Judge issue a ruling suspending the remaining procedural schedule in this docket.

On July 20, 2015, PGE filed a Motion to Suspend Non-Power Cost Procedural Schedule and Adopt Schedule for Remaining Issue. That motion indicated that all parties that had raised issues in this docket had reached a settlement of all issues except one power cost issue. The motion requested that the procedural schedule for non-power cost issues be suspended, and that an expedited schedule be set to address the one remaining power cost issue. Also on July 20, 2015, the Administrative Law Judge issued a ruling suspending the non-power cost schedule and setting a schedule for the one remaining issue.

Pursuant to that schedule PGE filed supplemental testimony on July 24, 2015, and Staff and the Industrial Customers of Northwest Utilities filed response testimony on August 5, 2015. Parties to the docket held a settlement conference on August 7, 2015. PGE, Staff of the Public


Utility Commission, the Citizens' Utility Board, the Industrial Customers of Northwest Utilities, and the Small Business Utility Advocates (collectively the "Stipulating Parties") participated in that settlement conference. As a result of those discussions, the Stipulating Parties have reached settlement of the one remaining issue in this docket. The Stipulating Parties are drafting a stipulation and supporting testimony and will file them as soon as completed.

Accordingly PGE, with the support of the other Stipulating Parties, requests that the Administrative Law Judge suspend the remaining procedural schedule in this docket.

Pursuant to the existing schedule for the non-power cost portion of this docket, PGE Reply testimony is due Friday, August 14, 2015. PGE therefore requests expedited consideration of this motion.
