13	Staff has contacted all parties to this docket regarding the proposed revisions and no party objects	
14	to this motion at the time of filing.	
15	The power cost hearing is currently set for July 30, 2015. Staff was notified by the	
16	Administrative Hearings Division that the Commission will not be available on that date. At a	
17	settlement conference on July 2, 2015, Staff raised this issue with the parties in attendance,	
18	including the Citizens' Utility Board of Oregon (CUB), Industrial Customers of Northwest Utilities	
19	(ICNU) and Portland General Electric Company (PGE). Of the alternate dates available, August	
20	13, 2015 worked best for these parties. Changing the hearing date requires adjustment of the	
21	remaining briefing schedule. Staff sent a revised schedule proposal to the parties in the docket by	
22	email July 6, 2015, which would adjust the dates for filing testimony, the hearing, and the briefing	
23	schedule. No party objects to the schedule prop	osed below.
