Legislation creating the Citizens' Utility Board of Oregon (CUB) was enacted into law in 1985. CUB was created to ensure that utility consumers have an effective advocate to reflect their needs and interests when it comes to public policies affecting the quality and price of utility services. ORS 774.020. CUB's membership averages 2,600 persons per year.

CUB intends to monitor the proceeding and, if necessary, raise issues that are appropriate to the proceeding. No other party could adequately represent the interest of utility consumers. CUB has participated in Commission proceedings since its inception in 1985.
