SECTION 63.71 APPLICATION OF
XO COMMUNICATIONS SERVICES, LLC AND XO VIRGINIA, LLC

XO Communications Services, LLC and XO Virginia, LLC (collectively, "XO")¹ submit this Application for authority under Section 214(a) of the Communications Act and Section 63.71 of the Commission's rules to discontinue² the following services (collectively, the "Affected Services") sold to retail business customers as specified below:

- XO Dedicated Transport Service;
- XO IP Virtual Private Network Service;
- XO Enterprise Session Initiation Protocol ("ESIP");
- XO IP Flex;
- Long Distance and toll-free services offered in association with XO IP Flex and XO ESIP (the "Affected Services").
