**SECTION 63.71 APPLICATION OF AT&T**

AT&T Services, Inc., on behalf of its affiliate, AT&T Corp. (referred to herein as "AT&T") applies for authority under Section 214(a) of the Communications Act, as amended ("the Act"), 47 U.S.C. § 214, and Section 63.71 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. §63.71, to discontinue AT&T Residential Local Service throughout its service territory in Arizona, Iowa, Idaho, Minnesota, Montana, Nebraska, New Mexico, North Dakota, Oregon, Utah, Washington, and Wyoming.

As required by Section 63.71 of the Commission's rules, AT&T provides the following information:

**Date of Planned Service Discontinuance:**

Effective on or after September 30, 2020, pending regulatory approval, AT&T Residential Local Service will be discontinued and will no longer be available for purchase by new or existing customers.

**Points of Geographic Areas of Service Affected:**

AT&T will no longer offer AT&T Residential Local Service throughout its service territory in Arizona, Iowa, Idaho, Minnesota, Montana, Nebraska, New Mexico, North Dakota, Oregon, Utah, Washington, and Wyoming.

**Brief Description of Type of Service Affected:**

AT&T Residential Local Service provides an end user customer with an access line that allows them to place and receive local, intrastate and interstate voice phone calls.

AT&T is discontinuing AT&T Residential Local Service because demand has declined significantly. The public convenience and necessity will not be impaired by the discontinuance of this service because AT&T is a reseller in this service area and replacement services are available from other carriers in these states, such as CenturyLink, the incumbent local exchange carrier throughout the affected service area.<sup>1</sup>

**Brief Description of the Dates and Methods of Notice to All Affected Customers:**

Customer notices were sent via U.S. Mail on June 26, 2020.<sup>2</sup> Copies of this Application are being sent, first class U.S. Mail to the public utility commission, governor, federally recognized tribes (if any) in the affected state, and to the Special Assistant for


