SUBJECT: PACIFIC POWER: (Docket No. ADV 47/Advice No. 15-008) Performs housekeeping to correct discrepancies in various tariff sheets.

**STAFF RECOMMENDATION:**

Staff recommends that the Commission approve Pacific Power's (Company's) Advice No. 15-008 and the proposed housekeeping revisions to its Rule 21 and Schedules 23, 90, 91, 295, and 748 be allowed to go into effect on June 24, 2015.

**BACKGROUND:**

On May 22, 2015 PacifiCorp (or Company) filed Advice No. 15-008—labelled "Housekeeping." The requested effective date is June 24, 2015. Revisions, with minor corrections noted, were submitted to the following tariff sheets: R21-8, 23-1, 90, 91-1, and 748-1. A minor update was also performed for tariff sheet 295.1.

On June 5, 2015 the Company filed, along with a Less-Than-Statutory-Notice Application, Advice No. 15-008—labelled "Housekeeping Replacement Tariff Sheet." The requested effective date is also June 24, 2015. The replacement sheet is Schedule 90—Summary of Effective Rate Adjustments. It adds the recently approved and effective Deer Creek Mine credits, Schedule 196, from Docket No. UM 1712, to the revisions made to Schedule 90 that were filed on May 29.

**APPLICABLE STATUTES AND RULES:**

Under ORS 757.205 (1), a public utility must file schedules showing all rates, tolls and charges for service that have been established and are in force at the time. Tariff

revisions or corrections may be made by filing revised sheets with the information required under the Commission's administrative rules, including OAR 860-022-0005 and OAR 860-022-0025. Filings that make any change in rates, tolls, charges, rules or regulations must be filed with the Commission at least 30 days before the effective date of the changes. A utility may make an application for a tariff or rate schedule to be effective on less than statutory notice. OAR 860-022-0020. Additional process is required when a new or increase in rates or schedules is proposed.

**STAFF ANALYSIS:**

Staff supports the corrections and other revisions as filed by PacifiCorp as appropriate. By their housekeeping nature, none of the corrections and other revisions affect customers' rates or tariff eligibilities. The Company has complied with the applicable filing requirements. Staff recommends the Commission approve this advice filing, allowing the housekeeping revisions to go into effect.

**PROPOSED COMMISSION MOTION:**

Pacific Power's Advice No. 15-008 be approved and allowed to go into effect June 24, 2015.
