Judge Grant,

Per your oral ruling on Wednesday afternoon, Surprise Valley and PacifiCorp have conferred about the procedural schedule in docket UM 1742 and discussed a two-week extension of the deadlines in the docket.

This extension would provide Surprise Valley with a full 15 days to respond to PacifiCorp's motion to suspend the procedural schedule and hold the case in abeyance. To ensure efficient use of party resources, the Commission would then issue a decision soon after Surprise Valley's response.

The parties have discussed a revised schedule. Because one of Surprise Valley's witnesses will be out of the country for a good deal of time, the parties propose extending the schedule out a bit longer than two weeks. Specifically, the parties would propose the testimony and hearing dates below.

PacifiCorp rebuttal testimony:	Current: April 26	New: May 17
SVEC reply testimony:	Current: June 14	New: July 15
Hearing:	Current: July 26-27	New: August 29-30

The parties agree the briefing dates should follow the hearing date using generally the same time spans in the current schedule, and ask for the opportunity to submit an agreed briefing schedule before the hearing date.

Separately, the parties have also agreed that Surprise Valley will file its reply to Surprise Valley's

motion to compel by Wednesday, April 13, 2016.

Thank you again for your assistance in this matter. Please let us know if there is anything else the parties can provide the Commission. We would be happy, for example, to file an agreed motion if it would be helpful.
