JOINT UTILITIES' MOTION TO MODIFY
PROCEDURAL SCHEDULE

(Expedited Consideration Requested)

1 In accordance with OAR 860-001-0420, Portland General Electric Company (PGE),
2 Pacific PacifiCorp d/b/a Pacific Power (PacifiCorp), and Idaho Power Company (Idaho Power)
3 (collectively, Joint Utilities) respectfully request that the Public Utility Commission of Oregon issue
4 an order modifying the procedural schedule in this docket.

5 On January 25, 2018, Administrative Law Judge (ALJ) Grant issued a notice (Notice)
6 soliciting comments on policy issues in this proceeding. In accordance with the Notice, parties
7 filed opening comments on February 14, 2018, and reply comments are due on February 21,
8 2018. A Commissioner workshop is scheduled for March 6, 2018. The Joint Utilities propose
9 changing the deadline for reply comments to February 26, 2018, which would provide
10 Commissioners and parties with just over a week to review reply comments before the workshop.
11 The Joint Utilities have conferred with the parties that provided opening comments in this
12 proceeding on February 14, 2018—Staff, Renewable Northwest, Industrial Customers of
13 Northwest Utilities, and the Northwest and Intermountain Power Producers Coalition—and all
14 parties either support or do not oppose the proposed modification to the procedural schedule.

15 Accordingly, the Joint Utilities respectfully request that the ALJ approve the proposed
16 revision to the procedural schedule changing the deadline for reply comments to February 26,
17 2018. Because the current schedule requires parties to file reply comments on February 21,

1 2018, the Joint Utilities request expedited treatment of this motion pursuant to OAR 860-001-
2 0420(6).
