SUBJECT: Stayton Cooperative Telephone Company, Advice No. 4/ADV 313 Revises tariff language and rates for Intrastate Access Service as required by FCC Order No. 11-161 and subsequent orders.

I have reviewed this filing and recommend that an acknowledgement letter be sent. The filing was submitted on May 27, 2016, and will go into effect on July 1, 2016. A supplemental filing was submitted on June 17, 2016.

Both filings revise Stayton Cooperative Telephone Company's Tariff PUC Or. No. 4, Access Services, as required by FCC Order No. 11-161, released November 18, 2011, and subsequent orders.

The May 27, 2016, filing revised all intrastate fixed and terminating switched access rates to be at parity with NECA's interstate switched access rates that become effective July 1, 2016.

The June 17, 2016, supplemental filing revised the Toll VoIP-PSTN Traffic Original Local Switching rate to be at parity with NECA's interstate switched access rates that were filed with the FCC on June 16, 2016.

In addition, the June 17, 2016, supplemental filing provided replacement sheets that revised Section 12.2.2(C)(1) of the Oregon Telephone Corporation May 27, 2016, filing and Section 12.2.2(A)(1)(d) of the Colton Telephone Company May 27, 2016, filing.
