

1. My full name is Stefan Brown. I am a Manager of Regulatory Affairs for Portland General Electric Company ("PGE").

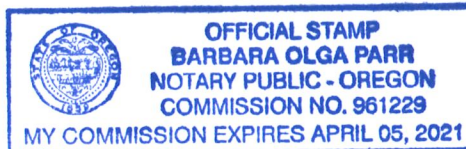
