

PGE notes that this case presents important legal and policy issues and believes that the Commission would benefit from an oral summation as well as the opportunity to pose questions to counsel. The Blue Marmots request that the

Commission not schedule oral arguments at this time, and instead allow the parties and Commission to review the filed legal briefs before deciding on whether oral arguments would be beneficial to the Commission in this case, or whether the testimony and legal briefing present a sufficient record upon which the Commission can issue its order.
