Avangrid Renewables is developer, generator, and marketer of electricity and related services. With more than 6,000 megawatts of owned or controlled assets, Avangrid Renewables is the third-largest generator of renewable electricity in the United States. Avangrid Renewables owns or controls the output of wind and solar plants in four of the six states in which PacifiCorp serves retail consumers and has a substantial renewable development pipeline in those states.

Avangrid Renewables has a substantial interest in this proceeding. The company submitted proposals in the solicitation which is the subject of this proceeding. Further, Avangrid Renewables anticipates participating in future solicitations tendered by electric companies subject to the jurisdiction of the Commission.

Avangrid Renewables has participated in numerous resource procurement solicitations across approximately two dozen states, and brings to the Commission an experience-based perspective that should help the Commission ensure that this procurement and future resource procurements are conducted fairly in the interest of Oregon electric customers.

Avangrid Renewables is a member of one intervening party, Renewable Northwest. As a unique commercial participant, however, Avangrid Renewables brings a perspective to the proceeding that may not be represented by Renewable Northwest. Intervention by Avangrid Renewables will not unreasonably broaden the issues, burden the record, or delay this proceeding.

Avangrid Renewables is aware that the proceeding is quite mature. Intervention at this point in the proceeding is timely, however. Avangrid Renewables has made

several inquiries subsequent to release of the final shortlist and supplemental testimony. Avangrid Renewables will analyze and may wish to comment on the pending report of the Independent Evaluator.

WHEREFORE, Avangrid Renewables respectfully requests that the Commission grant its petition to intervene with full party status in this proceeding and to appear and participate in all matters as may be necessary and appropriate; and to present evidence and argument and otherwise participate in the proceedings.
