2. I filed testimony (JOINT TESTIMONY IN SUPPORT OF PARTIAL STIPULATION/100) on behalf of PGE in this matter.


3. To the best of my knowledge, my pre-filed testimony is true and accurate. If I were asked the same questions today, my answers would be the same.
