**PARTIES' STATUS REPORT**

On July 23, 2018, the parties filed a joint motion for stay of time to respond to motion to compel. On July 24, 2018, Administrative Law Judge (ALJ) Allan Arlow granted the motion for stay and issued a ruling requiring the parties to file a status report with respect to their settlement negotiations on or before October 1, 2018.


On September 11, 2018, the parties filed a joint motion for stay of procedural schedule, requesting an indefinite stay of the procedural schedule, and noted the existing obligation to report on the status of their settlement efforts by October 1, 2018. On September 12, 2018, ALJ Arlow granted the motion for stay, suspended the procedural schedule indefinitely, and issued a ruling requiring the parties to file a status report on or before December 3, 2018, if motions have not been submitted prior to that date.

There have been no motions submitted since Judge Arlow's ruling on September 12, 2018. The parties are actively engaged in settlement discussions and anticipate finalizing settlement soon. The parties recommend that the ALJ continue the existing suspension. The

parties continue to reserve their rights to file motions, including motions for summary judgment, at any time.


