**PARTIES' STATUS REPORT**

On September 11, 2018, the parties filed a joint motion for stay of procedural schedule, requesting an indefinite stay of the procedural schedule. On September 12, 2018, Administrative Law Judge (“ALJ”) Allan Arlow granted the motion for stay, suspended the procedural schedule indefinitely, and issued a ruling requiring the parties to file a status report on or before December 3, 2018. On December 3, 2018, the parties filed a status report and requested a continued stay. On December 3, 2018, ALJ Arlow issued a ruling granting a continued suspension of the procedural schedule and directing the parties to file a status report on February 4, 2019.

There have been no motions submitted since Judge Arlow’s ruling on December 3, 2018. The parties are actively engaged in settlement discussions and anticipate finalizing settlement soon. The parties recommend that the ALJ continue the existing suspension. The parties continue to reserve their rights to file motions, including motions for summary judgment, at any time.


