**JOINT MOTION FOR STAY OF

Expedited Consideration Requested

Complainant Falls Creek Hydro Limited Partnership (“Falls Creek Hydro”) and Defendant Portland General Electric Company (“PGE”) request an indefinite stay of PGE’s deadline to respond to Falls Creek Hydro’s motion to compel discovery. The parties seek this stay because they are engaged in settlement discussions and believe it may be possible to settle this dispute without the need to resolve the pending motion to compel. Both parties reserve the right to move the Commission to lift this stay, in which case the parties agree that PGE’s response to the motion to compel will be due within 14 days of the order or ruling lifting the stay.

Falls Creek Hydro and PGE request expedited consideration of this unopposed motion and an immediate ruling that the deadline has been stayed.


