

PARTIES' MOTION TO SUSPEND  
ANSWER DUE DATE

*Expedited Consideration Requested*

Pursuant to OAR 860-001-0420(2), Portland General Electric Company ("PGE") and Red Prairie Solar, LLC ("Red Prairie Solar") hereby moves the Administrative Law Judge (ALJ) for an order or ruling suspending the due date for PGE to submit its Answer in the above-captioned docket.

PGE and Red Prairie Solar have had settlement discussions and have reached agreement in principle, and agree that the deadline for PGE's answer be indefinitely postponed. If settlement is finalized, then Red Prairie Solar will file a formal request that its complaint be dismissed.




